South Africa is one of the European Union's 10 Strategic Partners and the EU is South Africa's first investment, trading and development partner, accounting for a quarter of South Africa's trade and three-quarters of its foreign direct investment. Both partners are committed to strengthen multilateralism, peace and security, democracy, rule of law, free and fair trade and sustainable development.

## PARTNERS FOR INVESTMENT, TRADE AND JOBS



A large part of EU-South Africa trade is subject to privileged access each other's markets. The trade and investment relationship is governed by the EU-Southern African Development

Community Economic Partnership Agreement (EU-SADC EPA). As of 2016, the Agreement applies to the EU and six Southern African countries. Since the signing of the EU-South Africa Trade, Development and Co-operation Agreement in 2000, **trade in goods between the two has increased by more than 77%**. Since 2008, EU Foreign Direct Investment stocks in South-Africa has grown by 29%, to a total amount of €71bn in 2016.



**South Africa is the EU's largest trading partner** in Africa with exports to the EU growing and becoming more diverse, with an increase in the export of manufactured products.



**South Africa's primary exports to the EU are by order of importance,** machinery and transport equipment, fuels and minerals, agricultural products, as well as manufactured iron and steel products.



**EU exports to South Africa are dominated by machinery** (electrical and non-electrical) transport equipment, chemicals and other semi-machinery.



**Over 2,000 EU companies** sustain 500,000 jobs in South Africa.
