At its meeting of 14 June 2015, the Bureau of the ACP-EU Joint Parliamentary Assembly authorised its Committee on Social Affairs and the Environment to draw up a report, pursuant to Article 2(8) of its Rules of Procedure, on migration between ACP and EU Member States: causes, consequences and strategies for common management.

At its meeting of 24 and 25 September 2015, the Committee on Social Affairs and the Environment appointed Zamel Mohamed El Mokhtar (Mauritania) and Norbert Neuser as co-rapporteurs.

At its meeting of 4 December 2015, the Committee on Social Affairs and the Environment endorsed the replacement of Zamel Mohamed El Mokhtar (Mauritania) by Magnus Kofi Amoatey (Ghana) as co-rapporteur on the report.

The Committee on Social Affairs and the Environment considered the draft report at its meetings of 17-18 March 2016 and 11 June 2016.

At the last meeting, it adopted the accompanying draft motion for a resolution.

MOTION FOR A RESOLUTION

on migration between ACP and EU Member States: causes, consequences and strategies for common management

The ACP-EU Joint Parliamentary Assembly,

- meeting in xxx (xxx) from 13 to 15 June 2016,
- having regard to Article 18(1) of its Rules of Procedure,
- having regard to its previous resolutions, in particular that of 9 December 2015 on migration, human rights and humanitarian refugees,
- having regard to the Partnership Agreement between the members of the African, Caribbean and Pacific Group of States, of the one part, and the European Community and its Member States, of the other part, signed in Cotonou on 23 June 2000 (the Cotonou Agreement)¹, in particular Article 13 thereof, and to the revisions of the Cotonou Agreement adopted in 2005 and 2010²,
- having regard to the creation of the ACP Observatory on Migration,
- having regard to the Report on the 2011-2012 dialogue on migration and development endorsed by the ACP-EU Council of Ministers at its 37th Session on 14 June 2012 in Port Vila, Vanuatu,
- having regard to the Khartoum Process (EU-Horn of Africa Migration Route Initiative) and the Rabat Process (Euro-African Dialogue on Migration and Development),
- having regard to the European Parliament resolutions of 17 December 2014 on the situation in the Mediterranean and the need for a holistic EU approach to migration³, of 29 April 2015 on the latest tragedies in the Mediterranean and EU migration and asylum policies⁴, and of 10 September 2015 on migration and refugees in Europe⁵,
- having regard to Council Decisions (EU) 2015/1601 of 22 September 2015 and (EU) 2015/1523 of 14 September 2015, both establishing provisional measures in the area of international protection for the benefit of Italy and Greece,
- having regard to the communication from the Commission to the European Parliament, the European Council and the Council of 29 September 2015 entitled 'Managing the refugee crisis: immediate operational, budgetary and legal measures under the European





- having regard to the Charter of Fundamental Rights of the European Union of 7 December 2000.
- having regard to the Joint EU-Africa Strategy,
- having regard to the Joint Declaration and Action Plan, adopted at the EU-Africa Summit on Migration of 11-12 November 2015,
- having regard to the Sahel Regional Action Plan 2015-2020, adopted by the Council on 20 April 2015,
- having regard to the Convention for the Protection of Human Rights and Fundamental Freedoms,
- having regard to the Geneva Convention of 1951 relating to the status of refugees and its Protocol of 1967,

- having regard to the report of the Committee on Social Affairs and the Environment (ACP-EU/XXXXXXX),
- A. whereas wars, political, social and economic instability, economic downturn, poverty, poor governance, human rights violations, unemployment, corruption, political interference and repression, humanitarian crises, climate change and natural disasters, and growing disparities in living and economic conditions are the major driving forces behind migration;
- B. whereas climate change will lead to millions of people becoming migrants and the EU and ACP countries must commit to preventing the negative impact of climate change and to addressing its consequences;
- C. whereas regional instability and persistent conflicts have given rise to an unprecedented humanitarian crisis which led to the displacement of 60 million people in 2014;
- D. whereas policy coherence and coordination between the EU's external action, security, defence, trade, humanitarian aid, migration and development cooperation policies is of crucial importance but remains largely unaccomplished;

- E. whereas there is a clear need for a common approach to deal with the historic increase in migration, with coordination both within the EU and between the EU and ACP countries; whereas the Valletta Summit on 11 and 12 November 2015 was a courageous step in this direction but led to disappointing results;
- F. whereas organised criminal networks are exploiting migrants by charging large sums of money with the promise of safe passage across the Mediterranean into the EU through its southern borders, often ending in the tragic deaths of many migrants;
- G. whereas mobility, especially of students, professors and researchers, but also of workers and for the purpose of family reunification, has proven to be a powerful driver for development and poverty alleviation;
- H. whereas the colonial legacy, the attractiveness of welfare and benefit systems in many more highly developed EU economies, the demand for skilled labour, the prospect of better-paid jobs, and the encouragement given by the diaspora of many African peoples to family and friends to become migrants, are some of the pull factors causing migration from African states to the EU;
- I. whereas the duty of States is to effectively promote and protect the human rights and fundamental freedoms of all migrants in conformity with the Universal Declaration of Human Rights, the UN Convention on the Status of Refugees and the international instruments to which they are party;
- J. whereas many EU Member States also have real need of immigration for demographic reasons and for the promotion of cultural links;
- 1. Believes it is an unalienable right of any person to migrate in order to flee persecution or to search for better living conditions for him/herself and his/her loved ones, in accordance with Article 13 of the Universal Declaration of Human Rights; stresses that, while this is a liberty and a fundamental right that should benefit everyone, only some citizens are currently able to exercise it;
- 2. Urges the EU and the ACP countries to adopt and fully implement the UN 2030 Agenda for Sustainable Development, tackling in this way the root causes of migration by means of a holistic and integrated approach;
- 3. Calls on the parties to elaborate a concrete migration policy and a well-defined strategy on readmission and resettlement, and to cooperate with third countries to address the primary causes of displacement, such as conflicts, discrimination, poverty, corruption and poor governance, in order to achieve the Sustainable Development Goals;
- 4. Recalls that the final aim of any common migration policy should be not only to tackle the challenges of irregular migration but, more importantly, to take full advantage of the opportunities legal migration flows offer to both countries of origin and countries of destination;



- 5. Highlights the importance of mobility, especially for educational and employment purposes, in the context of tackling the root causes of migration and in general in the development agenda;
- 6. Recalls the importance of visa liberalisation, especially for students, professors, researchers and for the purpose of family reunification, which is also the best way to combat organised criminal networks' exploitation of migrants;
- 7. Underlines the importance of migrants' and migrant workers' rights to avoid exploitation and highlights in this regard the need to manage migration in both receiving and sending countries;
- 8. Urges a coordinated approach in mobilising resources needed to address the plight of migrants and refugees in or en route to EU Member States;
- 9. Recalls the importance of migrants' remittances and calls on the EU and ACP countries to introduce cheaper ways of transmitting remittances;
- 10. Calls on the parties to apply without delay the relevant provisions of the Valletta Action Plan for concluding visa facilitation agreements and to use the legal framework of the Rabat and Khartoum processes instrumentally in order to achieve this goal;
- 11. Praises in particular the Valletta provision to double the number of scholarships for students and academic staff through the EU-supported Erasmus+ Programme for 2016 compared with 2014; calls for a further increase of these scholarships;
- 12. Notes the establishment of the EU's Emergency Trust Fund for stability and addressing root causes of irregular migration and displaced persons in Africa ('Trust Fund'), including a provision of EUR 1.8 billion from EU funds and EUR 81 million from EU Member States; insists that the resources under this fund should be devoted to supporting relevant aid projects; stresses that development money must not be used for cooperation on border management and return; invites the Commission to fully ensure political accountability and financial transparency of the Trust Fund;
- 13. Reiterates that a holistic approach to the complex connections between climate change and migration, based also on the expertise the ACP Observatory on Migration could provide, is needed; believes that this integrated approach should consider, among other things, security, agriculture, environmental degradation and sustainable urban/rural development; demands, more broadly, that climate change be systematically integrated into all external policies and in particular development cooperation policies;
- 14. Praises the EU's support for the Nansen Initiative and the related Nansen Protection Agenda, focusing on the protection of people displaced across borders in the context of disasters caused by natural hazards, including those linked to climate change; encourages further reinforcement of the EU-created Global Climate Change Alliance to help poor developing countries most vulnerable to climate change to increase their capacities to adapt to its effects;

- 15. Urges that the topic of climate change and migration / environmental migration be included within the framework of the ACP-EU Dialogue on Migration and Development;
- 16. Calls on the EU to urgently allocate, within the ACP-EU Migration Action, technical assistance to the relevant ACP countries on aspects related to environmental migration, which is becoming increasingly crucial for them, both as an adaptation strategy and for disaster prevention;
- 17. Instructs its Co-Presidents to forward this resolution to the ACP Council of Ministers, the European Parliament, the European Commission, the European Council, the African Union, the Pan-African Parliament, the regional and national parliaments of the ACP countries and the EU Member States, and the regional organisations of ACP countries.

Introduction

Migration has existed as a phenomenon since human civilisation began, with individuals or groups of people moving from one place or country to another, either fleeing conflict or seeking a better life.

During 2015, migration into the EU from the Middle East, Africa and South Asia has increased to levels never seen before, with public opinion in EU Member States divided over what should be done to address the issue. The aim of this report is to assess the causes and consequences of migration, focusing on migration between ACP and EU states, and to recommend strategies for common management.

This working document pays particular attention to the outcome of the Valletta Summit on 11-12 November 2015, which was attended by the leaders of all the EU Member States and of many African States, as well as regional and international bodies.

It is clear that no continent or country alone can respond individually to the challenges of migration: it is imperative to have both African and EU countries on board. Partnerships at country and regional level are needed, with the highest possible level of ownership and commitment on the part of the countries of origin/transit/destination in a spirit of solidarity, shared responsibility and cooperation. Specific actions need to be tailor-made for key African partner countries, in line with specific country elements and risks.


The duty of States is to effectively promote and protect the human rights and fundamental freedoms of all migrants in conformity with the Universal Declaration of Human Rights, the UN Convention on the Status of Refugees and the international instruments to which they are party.

The current migration situation can only be addressed within the context of a holistic approach which should form part of a comprehensive overview of migration in the framework of the 2030 Agenda. A genuine response to the migration crisis in the EU and in Africa can only come from tackling the root causes.

Causes

The principal causes of the huge increase in migration in 2015 can be seen as the following:

- Conflicts and wars in countries or regions
- Poverty, economic under-development and inequality
- Human rights abuses
- Corruption
- Climate change leading to desertification and rising sea-levels
- Organised criminal activity in human trafficking and the falsification of travel documents



Migration from Africa into the EU is caused by many of the above factors to varying degrees, but it is clear that there is a mix of not only genuine asylum-seekers and refugees fleeing oppression, but also economic migrants. In a broader geo-political sense, some ACP countries accuse Western countries, including EU Member States, of causing conflicts and destabilisation in countries such as Syria, Libya, Iraq and Afghanistan through controversial foreign policy actions.

While a large proportion of migrants arriving in the EU come from conflict-affected places such as Syria or Afghanistan, there are considerable numbers form African countries such as Somalia, Eritrea, Sudan, South Sudan and Nigeria, where internal conflict and human rights abuses are common. There are also large numbers of migrants coming from further afield, for instance East Africa or West Africa, where the main driver of migration is economic.

Migration has existed in Africa for decades, owing to economic disparities between countries, with groups of individuals seeking employment or higher living standards in neighbouring states. More recently, with the economic crisis, there has been an increase in the phenomenon of North-South migration, with South Africa, for instance, seeing a big increase in migration from poorer countries in the region.

In addition to these "push" factors causing migration from African States to the EU, there are also "pull" factors, such as the attractiveness of welfare and benefits systems in many more highly developed EU economies, as well as the prospect of better-paid jobs. The diaspora of many African peoples already established in EU countries also use new technologies, now more freely available, such as the internet and mobile telephony, to encourage family and friends to become migrants.

It is also clear that organised criminal networks are preying on migrants by charging large sums of money with the promise of safe passage across the Mediterranean into the EU through its southern borders, often ending in the tragic deaths of many migrants. Many more perish during the long treks through transit countries in the Sahara desert.

Consequences

Migration has often been seen as a positive activity, both for the migrants themselves, who find safer havens or a better standard of living, and on account of the remittances sent by migrants back to their families and communities in their homeland, which make a considerable contribution to family and local economies. Immigrants have also been seen as making a positive contribution to the economies of the countries where they settle, often doing lower paid jobs which domestic workers are reluctant to do, and also enriching societies through multiculturalism. Immigration is also very necessary for many EU States for demographic reasons.

The recent surge in migration, accelerating through 2015, has, however, given rise to a much more negative attitude in many EU countries. In addition, many migrants are put in very dangerous or even deadly situations. Women and children are the most vulnerable and are often the victims of rape and other forms of abuse. Emigration further accelerates the brain drain from ACP countries, particularly of much-needed skilled people such as doctors and nurses.

It is estimated that millions of refugees will make the journey to the EU in 2015, with even more forecast for subsequent years. This increase has brought about a major development in the EU, with anti-immigration parties gaining power in a number of EU Member States. Mass immigration can have negative impacts, such as the financial burden of healthcare and education for migrants, conflicts in society due to cultural differences and problems in processing the huge number of asylum applications.

As far as the EU is concerned, it has been virtually impossible to reach agreement on a common approach to this increase in migration, and Member States have taken a variety of different measures to halt the flow of migrants, with the re-introduction of border controls, including in the Schengen area, and the erection of fences and walls. The attempt to impose quotas for refugees on Member States ended in failure, and policies are becoming even more divergent.

Strategies for common management


There is a clear need for a common approach to deal with this historic increase in migration, with coordination both within the EU and between the EU and ACP countries. The Valletta Summit on 11 and 12 November 2015 was a courageous step in this direction but led to disappointing results.

Its main recommendations establish five priory domains:

- 1. The development benefits of migration and addressing the root causes of irregular migration and forced displacement
- 2. Legal migration and mobility
- 3. Protection and asylum
- 4. Prevention of and fight against irregular migration, migrant smuggling and trafficking in human beings
- 5. Return, readmission and reintegration

Within these domains there are sixteen priority initiatives to be launched by the end of 2016, including:

- investment in development in poverty eradication
- support for resilience, in particular for women and children
- promotion of easier remittances
- action against conflict and conflict prevention
- supporting rule of law and good governance
- protection of refugees and humanitarian assistance



- fighting organised crime and terrorism
- improved border management
- cooperation to facilitate the safe return of irregular migrants

The Summit also saw the official signing of the EU Emergency Trust Fund for Africa, which will address the root causes of irregular migration. The EU contributes EUR 1.8 billion to the Fund, and EU Member States are supposed to contribute in an equally ambitious manner to the Fund. Member States' contributions so far have been disappointing, however.

With regard to specific migration between the EU and ACP countries, Article 13 of the Cotonou Agreement provides a framework for the management of migratory flows, including the protection of human rights, non-discrimination, and facilitation for students to have access to education and cooperation programmes.

The participants at the Valletta Summit were, however, unable to agree to the implementation of this principle despite the offer of EU funding to facilitate the process. The ACP States' ownership of their countries' policies also gives them the responsibility for providing a future for their own people in order to avoid a brain drain.

It is highly important to guarantee policy coherence and coordination among the EU's external action, security, defence, trade, humanitarian aid, migration and development cooperation policies.

Returns and all other related initiatives should go hand in hand with respect for the procedures and standards that allow the EU to ensure humane and dignified treatment of returnees, in line with the principle of non-refoulement.

Any EU policy on migration needs a real resettlement policy, a real strategy on readmission, and cooperation with third countries to address the root causes of migration (combating poverty, corruption and poor governance, achieving the Sustainable Development Goals, increasing development aid).

Our final aim must be not only to tackle the challenges of irregular migration but, more importantly, to take full advantage of the opportunities legal migration flows offer to both countries of origin and countries of destination.

In terms of mechanisms to implement a common strategy to manage migration, in addition to the Cotonou Agreement there is the Khartoum Process (EU-Horn of Africa Migration Route Initiative) and the Rabat Process (Euro-African Dialogue on Migration and Development), both of which are well established and should contribute to such management. In addition, the UN and its bodies, as well as the International Organisation for Migration, engage in activities in this area.

There is a clear need for urgent and common action in this difficult area, otherwise the levels of migration, and thereby the levels of suffering will continue to increase, and the stability of whole regions will become increasingly threatened.


